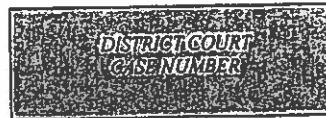

POLICE THE GUY WHO ASSAULTED [REDACTED] SGT DAVIS(2C09) ARRIVED ON SCENE. SGT DAVIS AND OFFICER JONES RESPONDED TO CLADDAGH PUB WITH [REDACTED] TO LOCATE THE SUSPECT. OFFICER JONES AND SGT DAVIS ALONG WITH [REDACTED] POINTED OUT A MALE LATER IDENTIFIED AS MR. MICHAEL FLAIG D.O.B. 04/09/1984 LOCATED ON THE SECOND FLOOR, SEATED AT THE BAR. 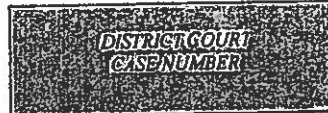

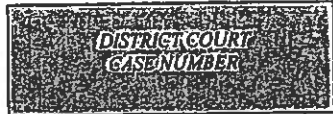
